


We are part of The Bartlett: University College London's global faculty of the built environment. The DPU has almost 70 years of experience in academic teaching, research, policy advice and capacity building in the field of international development.

DPU's Training and Advisory Services (TAS)

The DPU is proud to have a long history of working with organizations whose purpose and concerns resonate with our own vision of a **just world** in which men and women are equally able to choose, plan and manage their own lives and communities, and to influence local, national and global development in ways that are economically, socially and environmentally sustainable.

As part of our mission to build the capacity of professionals and institutions, the DPU undertakes action-oriented work with partners in different parts of the world. Regular contact with policy and planning practice is an important part of engaging with the theoretical and methodological debates pursued in our teaching and research. Central to this practice orientation are our Training and Advisory Services (TAS). When conducting our TAS work, we place a strong emphasis on understanding development contexts, and working with a range of development planning practitioners and institutions to build long term collaborations.

The DPU's TAS work is conducted with a wide range of different institutions, covering multilateral development organisations including United Nations bodies and International Financial Institutions, bilateral aid agencies, national and municipal governments, civil society networks, nongovernmental organizations, and private sector companies working in the international development sector.





The DPU offers four broad types of Training and Advisory Services:

Applied Research

In support of development interventions, this includes research for specific project cycle areas (for example, baseline studies, social and environmental impact assessments and project evaluations), desk-based research in support of issue-based topic guides,

and place and sector-based contextual research to inform strategic development work.
