#### 116. Students' Union UCL Budget 2024/25 (8-09)

- 116.1. John Dubber, Chief Executive, Students' Union UCL presented the paper which summarised the Students' Union's Budget for 2024/25.
- 116.2. The following points were raised in discussion:
  - a. Members welcomed the detailed analysis of past and future performance and noted that from 2025/26 there was a projected deficit for the SU budget.
  - b. In response to questions on the accuracy of the budget in future years, Tom Turner, Director of Finance Business Partnering (PSVP and Transformation), confirmed that the projections of the grant and staff costs aligned with the assumptions used for the UCL budget process. There had been a short-term uplift to the grant in 2024/25, but other options were being investigated by the SU rather than relying on additional support from UCL.
  - c. Mary McHarg, President of the SU, advised members that core efficiencies were addressed in all areas, but that options to close the budget gap would be unpalatable to students, and therefore the key would be to unlock the commercial potential of the SU. The Chief Executive, SU UCL outlined the options being explored to expand commercial revenue, including investigating whether it would be possible to perform commercial functions for other universities.
