Deaths



WHAT information are we collecting?

- Number of deaths in your care home
- Causes of deaths
- Dates of deaths

WHERE are we getting this information?

Office for National Statistics (ONS)

WHY do we need this information?

- To see how many COVID-19 related deaths there are in care homes
- To compare the number of deaths due to different variants of COVID-19



How is my personal information removed?




1. Original Information



We will use information that is already being collected by the NHS. This includes your COVID-19 swab test results, COVID-19 vaccinations, any A&E attendances or hospital admissions.

2. Removing Personal Information and Linking this to Data



Your personal information is removed and replaced with an ID number.

This is done by NHS England in line with the General Data Protection Regulations (GDPR) 2018.



3. Information Visible to Researchers

The VIVALDI dataset (which only contains information that cannot be used to identify you with) is sent to the VIVALDI study team by NHS England.

Who will have access to the data?



Only authorised VIVALDI study researchers will have access to the VIVALDI dataset which only contains information that CANNOT be used to identify you.

Authorised researchers have obtained all the necessary passports for data access and have completed training on data security. Members of the wider research team/ other university staff members will NOT have access to the VIVALDI dataset or any of your information.
